Governance of the Mexican State in the Context of Neo-Indigenism

Abstract

The speeches of the rectors of the Intercultural Universities (UIs) in the period 2019-2020 were analysed, which in the neo-indigenous context are part of the governance of the Mexican State. Through critical discourse analysis and an ethnographic method, the main categories found are described. According to the discourse, the UIs are referents in indigenous issues; they seek to preserve cultures, revive languages and incorporate knowledge. They promote dialogue for inclusion and integration of indigenous people into the society, but they are not considered as part of indigenous education. As part of the Mexican neo-indigenism, the speeches of the rectors are rather rhetorical, in accordance with the idea of governance, that they have the power to unite wills, since they may at a certain moment have been reality, but in practice they have not been demonstrated systematically.

Economic Development and Effectiveness of the Political Leaders: A study on the Role of the Elected Representatives in India

Abstract

This paper examines the effectiveness of political leaders of a democratic country like India measured in terms of the percentage of votes secured by them in the election and whether the role played by the political leaders in economic development impacts the same. The conceptual paradigm for this study has been drawn from Anthony Downs' 'An Economic theory of Democracy' (Downs, 1956), the theory of Collective Goods (Frohlich, Oppenheimer & Young, 1971), Game Theory (Brams, 2004) and the five-fold role model elucidated by Esther Cameron and Mike Green in their work "Making Sense of Leadership: Exploring the five key roles used by effective leaders" (Cameron & Green, 2009). Linear Regression Analysis of data from 445 Panchayats (the rural self-governing bodies, each covering a cluster of villages) and ULB Wards (the lowest self-governing units in urban areas) of nine constituencies of MLAs of a district of Odisha (a state on the eastern coast of India) establishes that on an overall basis a positive correlation between economic development undertaken by the MLAs utilising funds available to them through MLA-LADS, MP-LADS and SDP can be found with their electoral effectiveness. The variations among the political leaders in this field can, therefore, be explained in terms of difference in their leadership roles. It is thus suggested that a 'role mix' for undertaking economic development can enhance the effectiveness of political leaders.

Over the past thirty years, the resource-based view has been a valuable paradigm for explaining inter-firm differentials in organisational planning, programming, performing, profitability and development. This paper tries to answer the question whether the resource-based theory accounts for the persistence and development of intra-firm, inter-firm and inter-organisational development differences that is the subject of the resource-based theory and is the object of the master scholars substantiating the value of the resource-based theory. Based on investigation of four primary, one secondary and one tertiary method for strategic planning and decision making, the findings can serve as an urgent wake-up call for the researchers, practitioners, and policy makers to ascend their awareness about the contaminated pressures being experienced by the SMEs around the world. The study concludes that there is a critical need to nurture the primeval healthy cultural coefficient in which the SMEs can thrive and serve as units of dynamic technological growth for their own work culture system, their stakeholder organisations, as well as community ecosystems.


